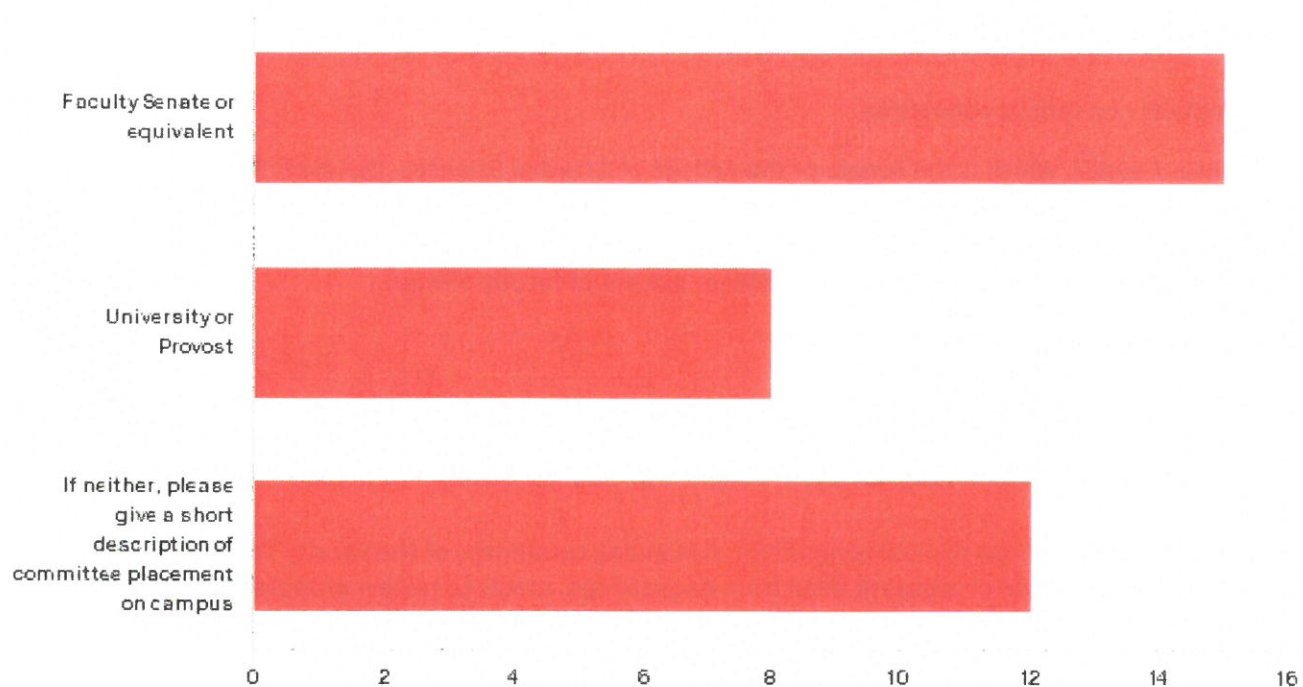

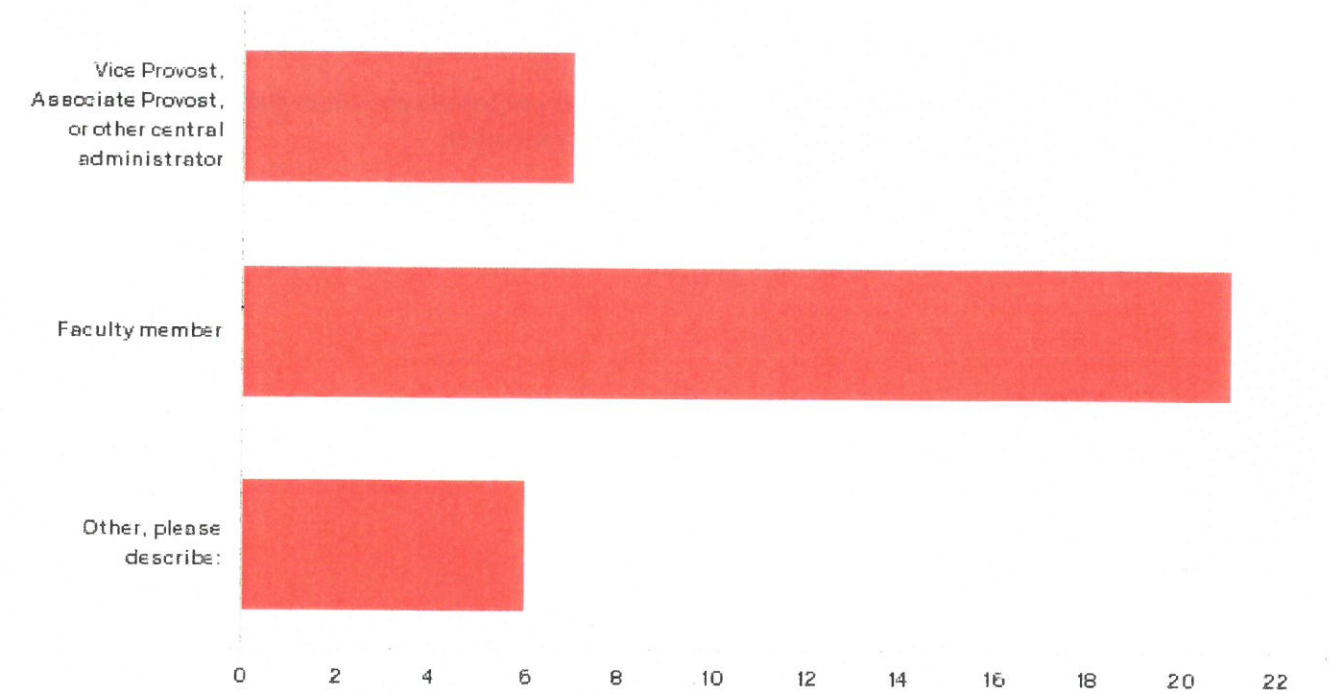

Q4 - Who is the Chair of the Committee? - Selected Choice



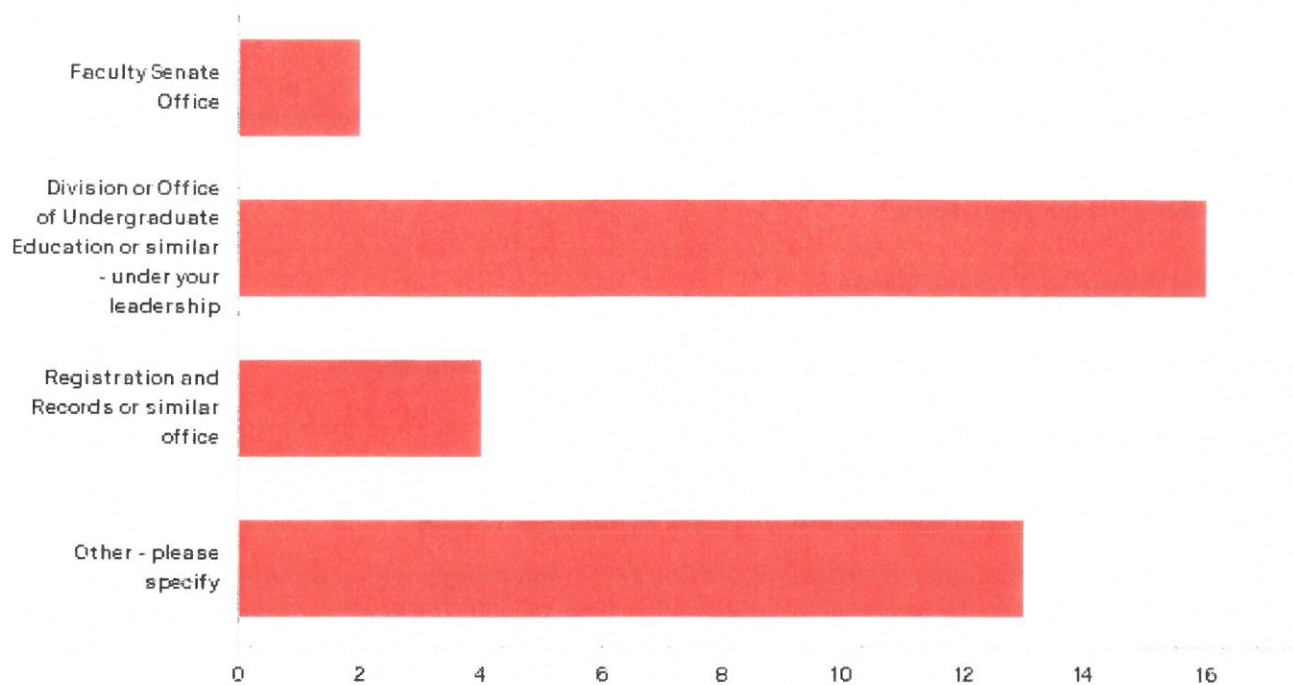

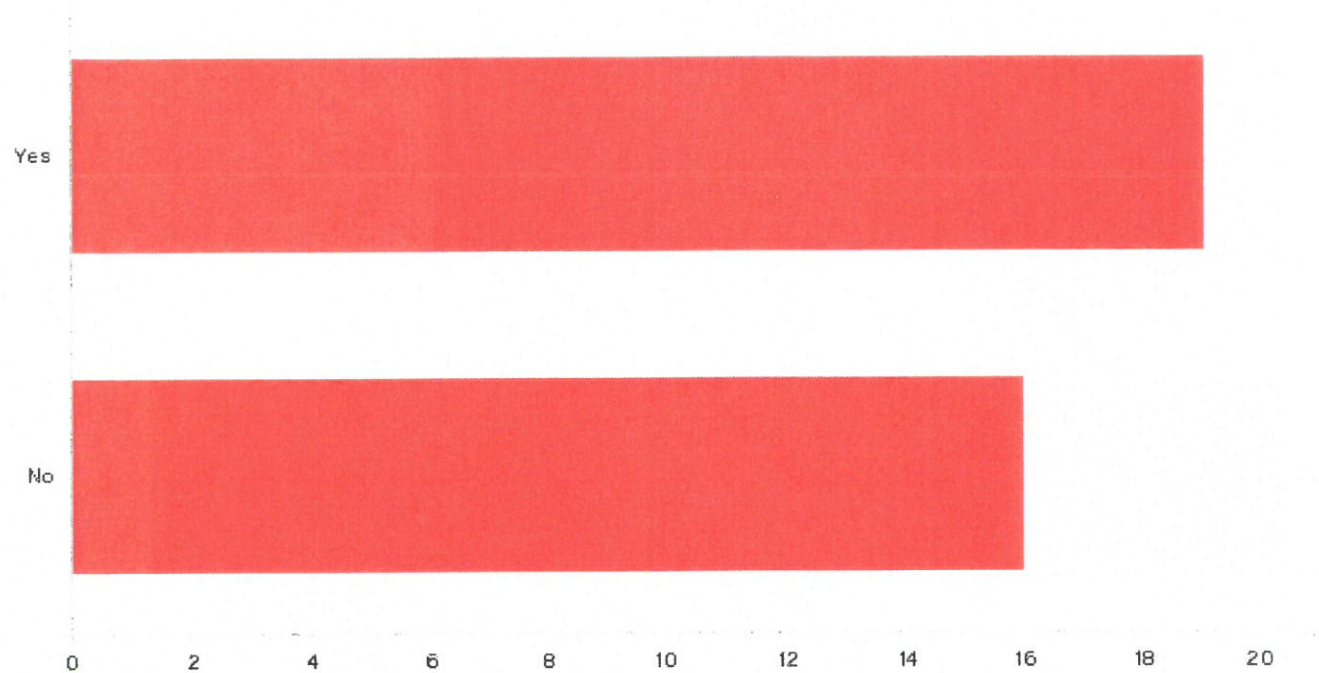
Q5 - Where does the administrative curriculum work get done? - Selected Choice

All new degrees, majors, minors and certificate programs are reviewed by the Administrative Boards of the College, which is run by the Dean and the senior Associate Dean for Undergraduate Education.

General Ed curriculum, the "Carolina Core". We also handle the University 101 course which is a 3-credit hour course that supports transition to college.

The Undergraduate Council (led by my office) serves as a committee that reviews new majors, minors, and certificates in case one school objects to negative curricular externalities that would be created by a program in another school. My office (formally, the Provost) prescribes the shape of certificate programs (e.g., number of courses, requirement of a coherent body of work not duplicated in work for a major, minor, or other certificate program) to ensure consistency across schools. My office also oversees the NROTC curriculum.

We have a Data Science Institute that reports to the Provost. Right now, they offer only a Master's degree. However, they are working on a minor and there may be certificates in their future (I do not anticipate an undergraduate degree at UVA in this area)

We have a university college unit that houses interdisciplinary certificates

Intercollege minors are formally housed in the OUE.

We have an Individual Studies program that offers a bachelor's degree. We have interdisciplinary minors in Asian American studies and cyber security.

General Education Wildcard Courses and Special 1-credit courses that do not fit within an academic unit (Building an Online Presence, Career Planning, etc.)

Pre-Law. (Formally, Leadership Studies.)

The Kilachand Honors College reports to the Associate Provost for Undergraduate Affairs. While students in the Honors College receive their degrees from one of the 10 undergraduate schools/colleges, participation in and completion of the Honors College curriculum appears on both the transcript and the diploma.

My "division" (the School of Undergraduate Studies) is an academic college but awards no degrees. We oversee a set of about a dozen interdisciplinary certificate programs, We also oversee the "gen ed" core curriculum, and an introductory first-year course for all first year students that is part of the core curriculum.

The Interdisciplinary Studies major, and three minor programs (Sustainability, Leadership, and Cybersecurity&Information Analysis) are housed in the University College, which is a unit housed within Undergraduate Studies (and for which I serve as the Director).
