## **Faculty Grievance Panel Selection**

Each college annually elects a number of faculty to serve a two-year term on the grievance panel; the number from each college is equal to one half of the number of senators from that college, rounded up when necessary, plus two.

Each college must elect one panel member each from the rank of Tenured Professor, the rank of Tenured Associate Professor, and the combined ranks of Assistant Professor and Special Faculty. Those colleges with more than three panel members elect additional members without restriction as to academic rank.

Eligibility for membership on the panel is the same as for serving on the Faculty Senate except that department heads may not be elected to the panels.

## **Faculty Hearings Committee Selection Procedures**

Committees formed from the Faculty Hearings Panel consider appeals from tenured faculty members in cases of suspension or discharge or cases of disruption.

Eligibility for membership is the same as for serving on the Faculty Senate with the exclusion of faculty without permanent tenure and members of the Faculty Grievance Panel.

Members of the Panel are elected for a four-year term. They are ineligible for immediate re-election.
