- **Hearing (603)**: Discharge for cause, serious sanctions
- **Grievance/Non-reappointment (604/607)**: general employment-related actions, including PTR, denial of promotion, non-reappointment

FAD

- Foundations of American Democracy
- No longer 3-credit hour minimum
- Changes to student learning outcome (SLO) wording

SLO 1: ~~Summarize and analyze~~ **Evaluate** key concepts, principles, arguments and contexts in the founding documents of the American Republic, including the United States Constitution, the Declaration of Independence, and **a representative selection of** the Federalist Papers.

SLO 2: ~~Summarize and~~ Evaluate key milestones in progress and challenges in the effort to ~~implement the founding ideals and~~ form “a more perfect Union,” including the arguments and contexts surrounding the Gettysburg Address, the Emancipation Proclamation, and the Letter from Birmingham Jail, as well as other texts that reflect the breadth of American Experiences.

FAD–Next Steps

- If approved, changes take effect July 2025
- Campus discussions about implementation
 - How to incorporate w/out going over 120 credits?
 - Cost? Resources?
 - How to avoid unintended consequences?

FAD/REACH Act



Both Maki and Hans said the goal is for “faculty” to retain “control” and that civics should not be confined to civics but instead taught across multiple “disciplines.” UNC can show its proposal is genuine by ignoring fringe faculty and instead adopting the same robust provisions of the REACH Act. Indiana Tenure Bill

- BOT must establish policies connecting tenure/PTR to:
 - Fostering a culture of free inquiry/expression and intellectual diversity
 - Exposing students to a “variety of political or ideological frameworks that may exist within and are applicable to the faculty member's academic discipline”
 - Not subjecting students to political/ideological views unrelated to the discipline
