Policy 200.8 on Chancellor Searches and Elections (adopted 05/25/23)

Section 2.1: "Consistent with state law...searches for chancellors of the UNC System shall be conducted as 'confidential searches,' which shall mean the identity of candidates, semi-finalists, or finalists shall not be disclosed to the general public. Conducting confidential searches is intended to maximize the quality of the candidate pool by not discouraging the interest of individuals who would not otherwise apply in the event of a publicly disclosed candidate pool."

Foundations of American Democracy

 NCSU: Starting conversations this semester with representatives of Faculty Senate, CHASS, DELTA, UCCC, CUE, OUCCAS

- Section 300.8.5 (+ REG) of UNC Policy Manual
- <u>Recording of PBS live stream of May BOG meeting</u> (start about 45 minutes in)
 - 2 governors made remarks in favor
 - 2 governors voted no
 - Motion passed

- Guidance provided by UNC System (scroll to end)
 - Reaffirms commitment to student success and academic freedom of faculty

 Permitted initiatives support student success, including those "tailored to the experience of students based in part on their race, sex, nationality...The Policy focuses on the content of programming and not the characteristics of the students receiving that support."

- Student success metrics in <u>UNC System Strategic Plan</u>:
 - Increase: 4-Year Graduation Rate, Undergraduate Degree Efficiency, Graduation Rate for Pell Recipients and Students of Color, Master's Degree Efficiency, Doctoral Degree Efficiency
 - Improve Student Mental Health

- Academic freedom leaves "space for the academy to teach, research, and serve free from the weight of administrative orthodoxy"
- Content "chosen by the professor as germane" is permitted
